The Field Trial Secretary will apply points to the top 5 placing hounds in the FIELD class in the following format: 1st – 10 points, 2nd – 8 points, 3rd – 6 points, 4th – 4 points, 5th – 2 points.

The Field Trial Secretary will apply points to the top 5 placing hounds in the SHOW class in the following format: 1st – 10 points, 2nd – 8 points, 3rd – 6 points, 4th – 4 points 5th – 2 points.

The Field Trial Secretary shall combine the placing hounds' field and show points. The hound with the highest point total will be awarded Grand Final Female/ Male accordingly

A HOUND PLACING IN THE FIELD AND SHOW WILL TAKE PRESEDENCE OVER A HOUND ONLY PLACING IN THE FIELD.

TIE BREAKERS:

1. The hound with the highest field placement shall win.
2. If field place is a tie, then the hound with the highest field points shall win.
3. If field points are the same, then the hound placing in the largest field class (defeated more field starters) shall win.
4. If field class is the same size, then the hound placing in the largest show class shall win.
5. A final tiebreaker shall be decided by drawing.
