





Club making motion: Clearwater Beagle Club

Article #9 "National Derby Run-Off"

Proposed Motion:

Clearwater Beagle Club moves that the current date set forth in the bylaws (18th Calendar weekend of the corresponding A.K.C. dates) be amended to a later date in either the month of October or November. We will keep the Derby cut off birth date at July 1st (in accordance with AKC), and UBGF Derby Qualifying trials for the New Fall Runoff would be allowed until June 30th. The consistency points would have a final calculation date of June 30th.


Allow UBGF to choose New Derby DATE in Oct - Nov.

This proposed change will be effective for the 2025/2026 Derby Season.


Comments Pertaining to Motion Change:

This proposed amendment would increase equal opportunity for hounds born later in the derby year (A.K.A short derbies), potentially increasing the number of entries and allowing time for clubs and members impacted by winter weather more opportunity for training their hounds- thus increasing participation. Additionally, a Fall Scheduled Trial grants more favorable running conditions for the hounds and the competitors. Favorable conditions include: cooler temperatures, less or no ticks and insects, higher visibility of the hounds for judging, and longer growing season for young rabbits, hopefully eliminating stress on the rabbit population and creating a more equal evaluation between packs.

PRESIDENTS REPORT:

Upon taking over for Marty Gibson, I opened the running grounds for running 7 days a week, daylight to dark, for trios, brace, and solos to get feedback on the rabbit population.

We have been working with Butler County to fence in the area behind the barn and kennels, which was voted on a few years back and will be used for a breeding pen.

I established a committee to look into the motion submitted last year by Jacks Creek on moving the derby runoff date.

We had the grounds sprayed for ticks this year, and using a drone in turn saved UBGF some money.

Baby rabbits have been seen in various locations, and as it stands now, Butler County plans on holding an October trial to see what rabbit population is available.

I sincerely want to thank the board for accepting my internship as President and for their dedication and service.

The Board wants to thank Butler County for the upkeep and continued maintenance of the facility for the welfare of the federation.

And lastly, on behalf of the UBGF, we want to thank the Sponsors for their unwavering support of the UBGF. We appreciate you all.

WELFARE OF THE FERATION:

Our main focus is raising rabbits and continuing to improve grounds with food plots, burning, limiting the number of briars, and splitting pens so we can get back on the UBGF grounds for our national events and continue working on financial welfare.
